There being 11of 14 current members of the Executive Committee present a quorum was present to conduct business.

The following guest was in attendance: Clint Daley from Flagship Health to discuss that they have closed Memorandum of Understandings with Endeavors, Steven Cowan Center, and VA; clinic is scheduled to open in December 2022. Mobile clinic will be rolled out on 15 November 2022. He requested to find out what time/day would be good for the mobile clinic to be present at the Post and to put out information to members.
